Orders will have to be confirmed in writing by sending an e-mail:

orders@a-emotionallight.com . All sales will be made according to the following terms, which must be accepted by the client when placing the order. This price list (RSP, VAT not included) substitutes all previous price lists.

1 - LEAD TIME:

The manufacturer will provide an estimated manufacturing time in the Order Confirmation, and it relates to the date on which the goods are ready to ship (Transport time is not included). This date is only indicative and not binding, so, the company will not admit any claims for delays on the shipping and delivery

dates or any other claims of whatsoever nature (claims for compensation, etc.), unless specifically agreed with the manufacturer.

2 - PRICES:

The Prices content in this Price List are in €, are Recommended Retail Prices, VAT Excluded, and it replaces any previous price list.

3 - PAYMENT TERMS:

Payment conditions will be agreed previously between Commercial Direction and customer.

Payment in Advance with Proforma Invoice will be applied for:

- The first order placed by a new customer unless another payment terms be agreed with the Commercial Direction.
- Orders placed by those customers who have deferred payment conditions, but they have not made any purchase in the last 12 months.

Deferred payment should be agreed between Commercial Direction and thE customer. The payment period starts just as of the date specified on the invoiceand the payment/s must be made on the exact due date/s. The invoice maturity date cannot be altered by the customer in any case and any bank charges which may arise as a result of late payment will be added to the invoice.

4 - DELIVERY CONDITIONS:

4.1 <u>UE COUNTRIES</u>: Orders will be served <u>DAP</u> (INCOTERMS 2020, ICC Paris). Orders less than <u>900 € Net Price</u> will be charged with 42€ for administrative expenses (Shipping & Handling).

Exceptions:

5-TRANSPORT DAMAGE AND CLAIMS:

Upon delivery of goods, the client must check and record in the delivery note, if there is any external sign of damage of boxes as well as if the carrier has mishandled the packages.

In the event the merchandise incurs in any damage during transport there is a maximum 24-hour period as of receipt of merchandise to give notice to our customer service department. After this period of time the manufacturer shall not be liable for any expenses originated from transport costs or repairs.

No claims and returns will be accepted without our authorisation, and a claim number will be issued. The claim number should be clearly visible on the label package of the returned lamp to be identificated on the arrival to our wharehouse. Goods received in our warehouse without previous notice or without a claim number will be returned to the sender.

The manufacturer will be liable for the repairs and transport of goods with a manufacturing fault prior inspection and confirmation of our quality control department once the godos have been received in our factory.

Handcrafted products may not be identical, and no claims will be accepted for slight variations in the form of the lamps. Opalescent glass may present on occasions, lines, dots, areas with different tones or irregular marks on its surfaces. All the above are characteristics of the handcrafting or the material and may not be considered defects.

6-CANCELLATION OF ORDERS:

There is a 48 hours maximum period in which orders may be cancelled as of receipt of the order confirmation. After this period no cancellations will be admitted.

7 - RETURN OF GOODS:
